2.0 Section-Sponsored Research and Applications

2.0.1 Machine Guarding on Agricultural Harvest Equipment (Combine)

Participants: Faculty Advisor Paul Ronczkowski. Student Section members: Justin Artman, Malaney Abel, Jonathon Mosby, Alena Puruncajas

Instructional Assistant Professor Paul Ronczkowski (faculty advisor for the student section), designed a research study that would utilize the efforts of student members, enhance their learning opportunities, with minimal complexity yet provide meaningful data for worker safety issues. Mr. Ronczkowski is a member of the Grain Handling Safety Coalition (GHSC, OSHA Harwood grant). His background in agricultural safety, as well as the professional relationships with the GHSC community, have helped focus on an area that does not receive much attention in research agendas.

This study is designed to focus on guarding on combines (agricultural harvesting equipment) used primarily for corn and soybean harvesting in the Midwest. Anecdotal information supports the idea that operators of modern combines rely on the implement dealer service departments for routine maintenance due to the complexities of electronics, computers, and other technology on this equipment. Four student members participated in this study, which proved to be a manageable number for the design of the project.

A literature review for previous work on combine guarding was conducted by the instructor, students, and the university research librarian. No comparable or supporting studies were found. The instructor and students also conducted a review of injuries and fatalities in the Midwest that were associated with combines.

Two of the students, along with the instructor, went to a local implement service shop. The manager of the shop graciously allowed them to look at combines and the guarding on these machines. At this point the students were not familiar with the operation of the equipment. After this review, a survey was then developed by the instructor and one student. The survey was anonymous. It addressed the age and make of the equipment. The concept was to have service managers and employees inspect and then indicate which guarding was missing or damaged when farmers or farm operators brought their equipment in for service. One of the students took the lead in contacting and visiting several implement dealers in central Illinois to

explain the survey and ask for their participation. The surveys were distributed in early March 2019 and then collected by the student.

This study has been accepted for presentation by the ASSP at the PDC in New Orleans June 2019. See Appendix C for details of the study.

- 3.1 Section-sponsored community activities:

3.1.1 Bright Horizons Safety Day

On October 26, 2018, the student section conducted a home and school safety training lesson with the Bright Horizons Pre-K class in Bloomington, IL. Three student section members, Justin Artman, Johnathon Mosby and Sarai Villegas, the Faculty Advisor, Paul Ronczkowski, spent an afternoon teaching proper handwashing techniques, home and kitchen safety and home fire safety. These lessons were taught in conjunction with Bright Horizon's Safety Week and the NFPA's Fire Safety Month. The student section also coordinated with the City of Bloomington Police, Fire and EMS departments to have emergency vehicles present at the school. The Pre-K class participated in a fire drill which led to the parking lot where they then received a hands-on experience with Police, Fire and EMS personnel. The entire Bright Horizons Center which consists of nine different aged classes, all had the opportunity to view and participate in the static display of the emergency vehicles. The student section also provided handouts and activities for the children to take home and complete with their parents. This included smoke detector test instructions and a home fire escape plan.

3.2 Section-sponsored campus activities

3.2.1 Homecoming Coffee Tent

The student section continued a tradition that was started almost thirty years ago of setting up the Homecoming Coffee Tent along the pre-game parade route on campus, October 13, 2018. Many safety alumni who attend the homecoming game and festivities stopped by the Homecoming Tent to visit with faculty and current students. The student section purchases coffee, soda pop, water, donuts and cookies and asks for donations from spectators along the parade route. A tradition that started in 2015 was to donate all proceeds to the ASSP Foundation. Three student members helped to set up the tent and coffee along with three safety program faculty. One student member worked the tent during the parade. (See October 2018 Newsletter in Appendix E)

3.2.3 American Heart Association Heart saver CPR Certification

On March 7, 2019, the student section coordinated and hosted an American Heart Association Heart saver CPR Certification. This was open to all programs in the Department of Health Sciences as well as some other invited departments across campus. Seven student section members, six other students from different majors, one faculty and one civilian employee for Illinois State University attended this event. The student section hosts this event at no cost to the participants. (See March 2019 Newsletter in Appendix E)

3.3 Section participation in community activities:

3.3.1 Festival of Trees for the Baby Fold

On November 5-7, 2019, four student section members designed and decorated two safety themed trees for the Festival of Trees auction. Justin Artman, Sarai Villegas, Alena Puruncajas and Paul Ronczkowski, Faculty Advisor then volunteered at the Festival of Trees in Bloomington, IL on November 14, 2018. This group helped to set up the hundreds of Christmas trees at the Bloomington-Normal Interstate Center to be bid on at auction for the Baby Fold's annual fundraiser. The Baby Fold is a statewide program that assists emotionally and physically abused children. Their goal is to improve the children's lives through foster care, education and other services. This year, the Festival of Trees raised over \$325,000 to aid our local community's Baby Fold operation (see Appendix D).

3.3.3 DIOSH Day

Downstate Illinois Occupational Safety and Health (DIOSH) Day is an annual, one day safety conference held in Peoria, IL. The planning committee asks that 6 student volunteers help with registration and lunch lines. In return, the Safety Program is given a booth in the exhibitor hall free of charge. The booth is a great opportunity for safety alumni who attend to visit with faculty. On February 27, 2019 six student section members worked to stuff attendee bags and help with registration, beginning their day at 6 am. The members also attended conference sessions after completing their assigned tasks. Four board members and four other members participated (see March 2019 Newsletter in Appendix E).

3.4 Section participation in campus activities:

3.4.1 Festival ISU Fire Extinguisher Training

Festival ISU is an annual event held early in the fall semester as a back-to-school event. Festival ISU allows all students to visit booths for approximately 400 of the different clubs, organizations, and community organizations available at ISU. The university's Environmental Health and Safety (EHS) office provided training and hands-on demonstrations of fire extinguisher use to students. On August 30, 2018 four student section members helped the EHS office at Festival ISU by operating the Bullex Grill systems, recharging fire extinguishers with water and pressure, and teaching hundreds of students the "PASS" method for extinguishing fires (see September 2018 Newsletter in Appendix E).

3.5 Section engagement with and/or support of the ASSP Foundation –

3.5.1 ASSP Foundation Donation

The student section raised \$182.00 in donations at their annual Homecoming parade coffee tent. Student Section members that attend Safety 2019 will present the donation to the foundation.

3.5.2 Other ASSP Foundation Involvement

The Illinois State University Student Section supports the ASSP Foundation in several ways. At the beginning of the academic year at our Fall Kick-Off Meeting, faculty and student section executive board members promoted Foundation news and ideas. The board provided information about the Foundation's mission, Foundation scholarships, and the Future Safety Leader's Conference. Additionally, throughout the Fall semester, board members provided reminders about scholarship application deadlines. Finally, several of our student members have attended CIL-ASSP Parent Chapter meetings and the Illinois State University Safety Program

Advisory Board meetings to discussed opportunities for alumni and professionals to assist the student section by supporting the ASSP Foundation.

Justin Artman, ISU Student Section President was the recipient of the 2018 Applications International Corporation \$15,000 Impact Scholarship from the ASSP Foundation. He was also the recipient of an Applications International Corporation Safety 2018 ASSP Foundation scholarship. Justin has also been notified that he will be a recipient of the 2019 Applications International Corporation \$10,000 Impact Scholarship for the ASSP Foundation (will be included in the 2019-2020 OSSA Application).

Johnathon Mosby, student section vice president, was the recipient of the Illinois State University Safety Department BCSP Scholarship. He also received the Safety Department Ron Budig Leadership Award.

Sarai Villegas, student section treasurer, was the recipient of the Omron Safety Scholarship.

Malaney Abel, student section community chair, was the recipient of the Association of Subcontractors and Affiliates (ASA) Chicago Scholarship and the Paul Ronczkowski Alumni Scholarship.

Tony Ludwig, student section member, was recognized as the Safety Program Scholar.







Appendix C: Research

Objective

The objective of this study was to look at farmers and farm operator's practice of repairing damaged guarding/ guard rails and/or keeping manufacturers guards/guard rails in place on a harvesting combine.

Introduction

Several factors were established as essential in the development of this research study. The study would focus on a meaningful safety issue that has minimal if any data from a research perspective in agricultural production. The study would involve student ASSP members. It would serve as a possible starting point for future more in-depth studies. It would be a survey study that would allow a more rapid collection of data. The survey could not be overly complex so that implement dealers' service managers would not be burdened in the collection of data. The survey needed to be developed in such a way that anonymity was preserved to gain the most participants possible. The study needed to focus on a small geographic location of Central Illinois.

Farmers are a resourceful group. They will repair or maintain their machinery or equipment as much as practical by themselves. However, based on anecdotal information from the experience of the student-faculty advisor (instructional assistant professor), most modern combines are serviced either at the service department of the dealership or on the farm by the service manager of the implement dealer. This is due to the complexity of the new technology on combines. A discussion with Dr. Robert Aherin, a leading expert in the field of agricultural safety was not aware of similar studies and also felt this could generate future studies on actual farms in looking at machine guarding.

The study did not focus on specific manufacturers of combines. The study looked at combines anonymously from random manufacturers. Regardless of the manufacturer, all combines will have guards on power transmission hazards that create shearing, cutting, pulling, wrapping and entanglement hazards. In addition, fall protection guarding is installed on access points and on top of the engine compartment and fire extinguishers are present as stock components, installed by the manufacturer.

A literature review was first conducted to look at studies specific to guarding of the power transmission of the combine. This review was conducted by the faculty advisor, one of the students and the research librarian at Illinois State University. No current or past studies could be found.

Moving forward from the literature review, the study team conducted a search for combine related fatalities and injuries. Fatality and injury databases were gathered from the agricultural safety extension services of University of Illinois and Purdue University in Indiana, the Kansas Farm Bureau, and the National Farm Medicine Center. A review of the fatalities and injuries during these time periods indicate most injuries and fatalities associated with combines are not occurring from entanglements, wrapping, etc. in the power transmission of combines. Injuries or fatalities were not occurring from falls off the engine compartment or access. However, further investigation needs to occur in the "other" category. But even if the "other" injuries and fatalities are associated with the power transmission of the combine, they would still not account significantly for the injuries and fatalities occurring. Results of this search are located in Appendix A.

Methodology

To develop a survey that would work for all service departments regardless of manufacturers, it was important to first educate the students on combines and secondly determine if there is any specific terminology that needed to be used. A phone conversation with the product safety group at Deere and Company gave good insight. A local Case IH implement dealer allowed the students to tour a combine and look at the specific types of guards, understand what the machine looked like and have an appreciation of the power and enormous size of these machines.

The final survey design is found Appendix B. Along with the survey a short instruction sheet was developed found Appendix B. One of the students then created folders that contained several survey forms, the instruction sheet and pockets for the completed surveys for each implement dealer. Two of the students accompanied the faculty advisor on the first two service department visits. A discussion on the study, the survey and reasoning were held with the implement dealers/owners and service managers. The decision to participate would be up to the dealers/owners. The study had one hundred percent participation of the service dealers visited for a total of five service centers located in Central Illinois.

One student then visited, and hand delivered the survey packets to service departments. A time frame was given to each service manager. The student then went back to each service department and collected the completed survey forms.

Results

The total number of surveys returned was 15. Of the 15 surveys, 6 of them had an indication of a missing or damaged machine guard, access railing or unserviceable fire extinguisher. This amounts to 40% of the combines surveyed having at least one machine guard, guard rail or fire extinguisher issue. 20% of the combines surveyed had two or more of the above issues. Results tabulation are located in Appendix C.


Future Work


One of the key factors that limited the number of surveys returned was the timeframe of planting and harvest season. The data collection began at a time when combines had been stored for the season or were not in use. All of the dealers that participated were able to give timeframes when combines will be in use and being serviced regularly. To continue to gather data, the survey will be given out to service dealers during the planting and harvest seasons. This will allow the study to capture a more accurate picture of working combines. Data will continue to be collected through April 2019 and then resume again in the summer of 2019.


Many of the fatality and injury databases, such as the National Farm Medicine Center, actively collect fatality and injury data. As the study evolves it will be necessary to continue to analyze new inputs. The study will also include an additional review of the fatality and injury types to further categorize the data.


Preliminary survey results showed an elevated fire safety concern in relation to combine injuries that were initially unforeseen. To capitalize on this information, further research is going to be conducted on combine related injuries, fatalities and property damage as it relates to fire, fire safety and any potential gaps in literature, training or other areas of interest.

Pre-K- Grade 1 Lesson Plans

OBJECTIVES

- Students will be able to identify the 4 steps for responding to the sound of a smoke alarm.
- Students will be able to apply the 4 steps for responding to the sound of a smoke alarm.
- Students will be able to accurately utilize ordinal language to represent a sequence of events.

Materials

"Little Rosalie" music video by SteveSongs Smoke alarm with battery Fire Escape Message Cards (1 set per student and a teacher set) White construction paper Crayons, pencils, glue

Instructions

REVIEW teacher information so you have a good understanding of smoke alarms and the correct response to the alarm.

ACCESS smoke alarm prior knowledge using a KWL chart.

DEMONSTRATE the sound of the smoke alarm with students (beep, beep, beep, pause, beep, beep).

HAVE students turn to a partner and discuss reasons why a smoke alarm would sound. Have students share with class.

SHOW the "Little Rosalie" music video.

DISCUSS the 4 things to do if the smoke alarm sounds (beep, beep, beep, pause, beep, beep, beep) using the Fire Escape Message Cards:

- 1. Get up and walk, don't run, but you should walk briskly.
- 2. Remember to know two ways out of every room.
- Get yourself outside quickly.
- 4. Go to your outside meeting place with your family.

SHOW a Fire Escape Message Card and ask students to describe the illustration. What is the illustration telling you?

DISTRIBUTE a set of Fire Escape Message Cards to each student. Have students work in pairs to discuss each illustration and what it is telling them about responding to the sound of the smoke alarm.

HAVE each student put the cards in correct order. Have students turn to a partner and discuss the order of their cards to be sure they are correct.

STAPLE 5 pieces of construction paper together to make a book for each student. Have students paste the cards in order in their book and create a cover. Students can write 1–4 to help put the steps in order.

ASSESSMENT

Provide students with construction paper. Students will summarize the 4 steps for responding to a smoke alarm through illustrations. Older students can write a sentence for each illustration using ordinal language (first, second, third, and last).

TEACHER INFORMATION

SMOKE ALARMS SAVE LIVES. Every home needs smoke alarms. They should be installed on every level of the home (including the basement), outside each sleeping area, and inside each bedroom. A smoke alarm makes a, "beep, beep, beep" sound. Between each set of three beeps is a slight pause -- "beep, beep, beep, pause, beep, beep, beep, pause," and so on. A smoke alarm senses smoke. It will sound if there is smoke in the home — possibly from a fire. When the smoke alarm sounds, everyone should leave the home. Everyone should know the sound of the smoke alarm and how to respond quickly.

A HOME FIRE ESCAPE PLAN is a plan to get out of the home quickly in case there is a fire. Every room in the home needs two ways out. One way out would be the door and the second way out may be another door or a window. Every home fire escape plan needs an outside meeting place. A meeting place is a permanent location in front of the home, a safe distance from the home. A good meeting place might be a neighbor's home, a street light, a mailbox, a neighborhood store or a special tree. Everyone in the family should go to the meeting place so everyone will be together and grown-ups will know that everyone is safe. Families should practice their home fire drill at least twice a year.

Here are the 4 important things to do if the smoke alarm sounds:

- 1. Get up and walk, don't run, but you should walk briskly.
- 2. Remember to know two ways out of every room.
- 3. Get yourself outside quickly.
- 4. Go to your outside meeting place with your family.

AS PART OF FIRE PREVENTION WEEK, your child has been learning about smoke alarms. Working smoke alarms save lives. That's right, having smoke alarms in your home is very important. Smoke alarms let you know there is a fire. Working smoke alarms also give you time to get outside and stay outside if there is a fire.

Follow the steps below to check the smoke alarms in your home.

Your child can help, too!

- LOOK around your home and make sure you have a smoke alarm on every level and inside every room where people sleep.
- PRESS the "Test" button on each smoke alarm. If the smoke alarm makes a "beep, beep, beep" sound, it is working. Make sure you test each smoke alarm every month.

- 3 If the smoke alarm does not make a sound, **REPLACE** the battery or batteries. If it still doesn't work, replace the alarm.



ARTICLE 1 - NAME

Section 1. The name of this Section shall be the Illinois State University Section of the Central Illinois Chapter, American Society of Safety Engineers.

Section 2. Hereinafter, the Student Section shall be referred to as the <u>Section</u>, the American Society of Safety Engineers shall be referred to as the <u>Society</u>. The Central Illinois Chapter shall be referred to as the <u>Chapter</u>, the Area Operating Committee shall be referred to as the <u>AOC</u>, the Regional Operating Committee shall be referred to as the <u>ROC</u>, and the Illinois State University/College shall be referred to as the <u>School</u>.

ARTICLE II - PURPOSES AND GOVERNMENT

Section 1. The purposes of this Section shall be to promote the advancement of the safety profession and safety education and to foster the professional growth and development of its members within its campus and community.

Section 2. In fulfilling its purposes, the Section shall have the following objectives:

- a.) To further the professional preparation of the members by sponsoring programs for the advancement of safety and acquisition of technical knowledge.
- b.) To improve scholarship and the general quality of work in the Safety Profession by fostering a concern for progress in all areas of safety, among safety educators and practitioners.
- c.) To encourage greater professional and social cooperation and interaction among students of safety and allied fields and disciplines.
- d.) To unite the resources and skills of students and faculty in programs to benefit Section members, the school and its community.
- To assist the Society in the development of effective and relevant educational programs for the preparation of future safety professionals.
- f.) To provide encouragement and support to society student activities and foster student member development and retention on its local campus.
- g.) To promote participation and entrance into safety/health careers by high school and college students.
- h.) To cooperate with other professional societies and organizations to further the purposes of the society
- To conduct, assist, and support educational activities designed to equip individuals with the knowledge necessary to practice safety.
- j.) To promote the observance of the "canons of ethics" adopted by the society.
- k.) To set up speaking engagements for the purpose of promoting an interest in safety within the section and the university.

- Section 3. This organization shall be governed by this constitution and bylaws and regulations of the Chapter and the ASSE.
- Section 4. The headquarters of the Section shall be located at Illinois State University, Department of Health Sciences, 305 Felmley Hall, Normal IL 61790.
- Section 5. The official symbol of the section shall be the same as that of the Chapter and Society.
- Section 6. Nothing in these bylaws is intended to substitute for, or supersede, rules or procedures established by the school that impacts upon the Student Section.

ARTICLE III - MEMBERSHIP DUES AND FEES

- Section 1. Section membership is open to all Student Members of the Society, who are enrolled in the safety or related curricula at the school identified in the Section's name. To be eligible as a Society Student Member, an individual shall be enrolled in an undergraduate or graduate safety course intended to prepare the individual for practice in the safety profession or on of its relevant specialties, shall pay an annual renewal fee as designated by the Society Board of Directors.
- Section 2. Section members shall be assessed an annual student member renewal fee by the Society as determined by its Board of Directors. In addition, applicants for Student Membership may be assessed membership application fees as determined by the same Board. Fees shall be paid annually on the anniversary of the Student Member's election date.
- Section 3. The Section may assess its members additional annual fees and dues, upon recommendation of the Section Executive Committee and approved by a majority of Section members voting at a meeting where a quorum is present.
- Section 4. The Section Executive Committee, through the Section Treasurer, is responsible for all Section financial activities, under guidelines established by the Society, Chapter, these Bylaws, and the Section Executive Committee.
- Section 5. The Section shall provide an annual financial report to the Chapter, Area Operating Committee (Regional Operating Committee) and Student Member Activities Committee, describing all Section income and expense activities for the preceding twelve

- (12) months. This report shall be reviewed and signed by the Section Advisor and submitted to the Chapter by April 15.
- Section 6. Student Member status, may be retained up to one year following graduation, or until the individual is employed in the field of safety, whichever comes first.
- Section 7. Section membership is personal and non-transferable..
- Section 8. Section members are eligible to vote on all matters brought before them. A majority affirmative vote is necessary for action unless otherwise specified in these bylaws. On Chapter and Society issues, Student Members are eligible to vote only on the election of officers.

ARTICLE IV - ORGANIZATION

- Section 1. The Section is a subdivision of the Chapter, formed and operated by ASSE Student Members attending an educational institution located within the Chapter's geographical area.
- Section 2. The Section shall have and maintain a minimum of five (5) members in order to maintain its charter.
- Section 3. In order to maintain its charter, the Section shall identify an advisor (defined in Article V, Sec. 6) and shall provide the Chapter and Society annually with information on the advisor's name, address and telephone number.
- Section 4. Formation and maintenance of the Section charter is based on requirements and guidelines set forth in the <u>Chapter Administration Guide</u>, and is subject to the approval of the Chapter and the appropriate AOC (ROC).
- Section 5. The Section may be dissolved by the Chapter and /or the AOC(ROC), if such action is deemed to be in the best interests of the Chapter and Society. Voluntary dissolution of the Section shall be by two-thirds of Section members after a 30-day advance written notice by the Section Executive Committee. Voluntary dissolution is subject to the approval of the Chapter and AOC (ROC). Upon dissolution, all Section funds and assets shall be returned to the Chapter, school, ASSE Foundation or other ASSE entity, depending on the funding source.

Section 6. The Section fiscal year shall begin on April 1 and end on March 31. The Section activity year shall begin on April 1 and end on March 31.

ARTICLE V - OFFICERS

- Section 1. Elected Section officers shall be a President, Vice President, Secretary and a Treasurer. Requirements for Officers are as follows:
 - a.) President and Secretary: Any permanent member may be elected to these offices.
 - b.) Vice President: This office should be filled by any permanent member of the Section who knows to the best of his knowledge he will be able to complete his term of office.
 - Treasurer:
 Any Permanent member may hold this office.
- Section 2. Elections for all officers will be held during the last meeting of the school year.
- Section 3. Prospective officers will be asked by the Executive Committee if they will accept their nomination to office, how long they will be able to retain their office and state their qualifications for the office they intend to hold.
- Section 4. Vacancies caused by non-returning officers to the University and those who can not fill their office for the remainder of the term will be filled by the Executive Committee calling a special election meeting.

Section 5. Duties of officers:

a.) The President shall call, set agendas for, and preside at meetings of the Executive Committee, and preside and set agendas for meetings of the Section membership; shall set goals and objectives for the section and provide leadership, guidance and direction to officers, committees and members to see that they are met; shall appoint members of the Nominating Committee; shall serve as chief spokesman and representative of the Section to the Chapter, Society and allied groups; and shall submit an annual report of Section activities to the Chapter and Student Member Activities Committee. The president shall serve in the capacity of a non-voting member on the Safety Program Advisory board for the duration of an entire academic year. The president will begin in this capacity at the May advisory board meeting following the April student meeting elections. The president would be invited to attend the following May meeting when the newly elected president would assume the duties.

- b.) The Vice President shall succeed to the office of the President if the President is unable to serve; shall act for the President when requested to do so by the Executive Committee or members; and shall in general prepare to ascent to the Section Presidency in the following year.
- c.) The secretary shall record, transcribe and distribute minutes of all Section meetings, prepare and distribute meeting notices, maintain all Section records and conduct Section membership development and retention activities under the supervision of the Executive Committee.

NOTE: The President-Elect or Vice President may also supervise the work of Section appointed committees or project Chairpersons, if desired.

d.) The Treasurer shall collect and disburse all Section funds, maintain Section financial records including all income and expense activities, collect Section-generated membership fees and dues, handle all Section liaison with financial institutions, submit an annual report of all Section financial activities to the Executive Committee, and keep the Section and the Chapter regularly informed as to the Section's financial status.

Section 6. There shall be a Section advisor who shall be either:

- An ASSE member who is a faculty member of the school where the Section is located, or
- A formally designated member of the Chapter in whose geographical area the Student Section's school is located.

The advisor shall be an ex-officio member of the Section Executive Committee, and shall serve as liaison between the Section, appropriate school officials, and the Chapter. The advisor shall approve Section activity and financial reports, fundraising activities, and be consulted on all matter relating to Section dues, fees, and Bylaws. The advisor shall ensure that Section activities do not violate School rules and regulations governing on-campus clubs, groups, and activities.

ARTICLE VI - NOMINATION, ELECTION AND REMOVAL OF OFFICERS

- Section 1. The Nominating Committee shall be appointed by the Chairperson/President annually for the purpose of recommending a slate of one or more nominees for each Section elective office. Publication of the slate, including background and qualifying information on each nominee, shall be completed no less than thirty (30) days before the election is conducted. The election and installation of officers for the succeeding Section activity year shall be completed before the end of the current school year.
- Section 2. The term of service for officers shall be for one (1) year beginning July 1.
- Section 3. Five to seven (this should be the number of student members who can submit the petition) Student Section members may submit a signed petition nominating one or more members for elective office. The petition shall be accompanied by a written acceptance by the nominee (s) and shall be submitted to the Nominating Committee Chairperson no less than fifteen (15) days before the election is conducted. The names and qualifications of the petition nominees shall be distributed to all members within seven (7) days of their receipt.
- Section 4. All Section members shall be given the opportunity to vote on the election of officers, through written ballots distributed on campus and/or at a Section meeting.
- Section 5. Three Section members, who are neither candidates for elective office, nominating committee members, no current Section officers, shall be appointed as Tellers to count ballots confirm the propriety of election/nomination procedures, and announce election results.
- Section 6. Elected Section officers may be removed by majority vote of Section members at any regular or special meeting upon presentation of a signed petition from the Section Executive Committee or this should be five to seven Student Section members. Notification of such meeting shall be made to all members at least fifteen (15) days in advance of the meeting.

Appointed Section officers may be removed by the officer who appointed them, or by the Section Executive Committee.

Section 7. Vacancies in elected Section offices occurring during the elected term shall be filled by the succession designated in Art.V, Sec.5. The resulting Vacancy in the office of Treasurer shall be filled by affirmative vote of a majority of Section members upon a nominating slate of one or more candidates submitted by a special member Nominating Committee appointed by the Chairperson (President). The election shall be held at a regular or special Section meeting, notice for which shall be published at least fifteen (15) days in advance.

ARCILE VII - COMMITTEES

- Section 1. Elected Section officers and the Section advisor shall make up the Executive Committee, which shall govern the Section according to these bylaws and within the authority delegated to it by Section members.
- Section 2. The Section shall have a Nominating Committee, appointed by the Chairperson (President), for the purpose of developing a slate of Section officers annually for member election. The committee shall consist of three Section members, one of who shall be a current or past Section officer. The committee shall elect its own Chairperson.
- Section 3. There shall be an Executive Committee, consisting of the elected officers.
- Section 4. The Executive Committee shall meet at least 6 times a year to transact the business of the Section. A quorum shall consist of a majority of the members of the Executive Committee.
- Section 5. The Executive Committees shall be responsible for the policies and programs of the Section. The Executive Committee shall have full authority to act for the Section and to take all steps it deems necessary or appropriate to carry out the Section's purposes. The Executive Committee shall be responsible for the finances of the Section.
- Section 6. The President shall appoint the Chairs of such standing committees as are established in the bylaws, and such special temporary committees as may be necessary to accomplish the purposes of the Section.

ARTICLE VIII - AMENDMENTS OF CONSTITUTION

- Section 1. This Constitution may be amended by approval of 2/3 affirmative votes cast by permanent members at a regular meeting of the Section. Amendments may be proposed either by resolution of the Executive Committee, or by petition signed by not less than 5 permanent members of the Section. All proposed amendments shall be submitted to the secretary in writing. Amendments originating in the Executive Committee shall be certified by the President before they are submitted to the secretary.
- Section 2. All proposed amendments received by the Secretary shall be submitted in writing to each member at least 14 days prior to the meeting at which a voice vote shall be taken on the proposed amendment.

ARTICLE IX AMENDMENT OF BYLAWS

- Section 1 The bylaws may be amended by a proposal of the Executive Committee. The amendment shall be presented and read at a regular meeting of the Section. The proposed amendment shall then be voted on at the next regular meeting of the section by a voice vote. A majority vote of members present shall prevail.
- Section 2. Amendments shall be published at least fifteen (15) days in advance of the meeting at which action will be taken on them.
- Section 3. Amendments shall be voted on at a regular or special Section meeting where a quorum is present. A majority (option two-thirds) 2/3 affirmative vote is required for approval.
- Section 4. All amendments approved by Section members are subject to approval of the Chapter Executive Committee and Area Director (Regional Vice President).

ARTICLE X – MEETINGS


- Section 1. The Section Executive Committee shall meet upon the call of the President or upon a majority vote of its members.
- Section 2. The Executive Committee shall hold at least two (2) meetings of its members annually, to acquaint them with its activities and conduct necessary business. Five to seven section members at a meeting shall constitute a quorum.

- Section 3. Special meetings of Section members may be called by the Section Executive Committee or by written petition of five (5) members, submitted to the Section President.
- Section 4. Section member meetings and votes shall be required to accomplish the following actions: amendment of these bylaws, establishment of or change in Section dues or fees, removal of elected officers, and Section dissolution.
- Section 5. The Section shall hold six (6) meetings throughout the academic year, which consists of the spring and fall semesters.
- Section 6. Robert's Rules of Order Newly Revised shall govern the transactions of business at Section meetings, unless otherwise specified in these Bylaws.
